


# Serious **Traffic** Offender Program Revoked Suspended































































- In 2004 Rapid City, SD had six fatal crashes
- Out of those six fatal crashes, there was a <u>Suspended or</u> <u>Revoked Driver</u> involved in four out of those six fatal crashes
- That in turn means there was no insurance for those vehicles as well
- The Rapid City Police Department reviewed the issue and decided to target suspended and revoked drivers
- The Police Department wrote a grant to the South Dakota Office of Highway Safety requesting a grant to fund a STOP Officer and a Sergeant to administer and oversee the program



- All licensed drivers in Pennington County had a license status check done
- 1,350 drivers in Pennington County had SUSPENDED OR REVOKED licenses
- Because of the number of Suspended and Revoked Licenses, a plan was developed to have a manageable number
- It was decided to target the most dangerous drivers



- Drivers' histories were run for a five year period
- Points were assigned as follows

5 Points

DUR5 Points

DUS5 Points

Reckless Driving4 Points

Careless Driving3 Points

Speeding Offenses3 Points

Stop Signs & Red Lights 2 Points



- With points assigned, a "TOP 100" list was formed
- Also, a "2<sup>nd</sup> 100" list was formed to track drivers who were moving up quickly
- The lists are run every 6 months to "refresh" the most dangerous drivers
- The lists are refreshed in conjunction with our semi-annual shift bids and rotations



- Patrol Shifts are frequently briefed on the Top 200 Serious Offenders
- The TOP 10 OFFENDERS have a Traffic Officer personally assigned to them
- Traffic Officers will periodically make contact with the offenders at home or work as a reminder the POLICE are paying attention
- The goal of the program is to persuade the offenders to comply with the law



#### OFFICER INVOLVEMENT

- The key to success for the STOP Program is to get a buy-in from the street officers
- Officers are briefed regularly on our achievements and praised for their good work
- A positive for the officers is that all cars are towed unless there is a licensed, insured driver seated in the vehicle at the time of the stop
- Towing the vehicles ended up being very popular among the officers



#### **Judicial Involvement**

- State's Attorney and Judges were introduced to the program before it was sent to the Street Officers
- Judges asked for a common court date
- State's Attorney was given a list of offenders and actually track the offenders through the court trials
- Mandatory Court Appearances are required for all Suspended and Revoked Drivers



#### **Judicial Involvement**

- Judges agreed to harsher sentencing for the Top Offenders
- Offenders in the Top 200 are sentenced to one day in jail each time they are cited for DUS or DUR
- Offenders in the Top 100 are sentenced to two days in jail each time they are cited for DUS or DUR
- Offenders in the Top 10 are sentenced to five days in jail each time they are cited for DUS or DUR



#### **Media & Public Relations**

- To begin the STOP program, a letter was mailed to each of the Top 100 Offenders introducing them to the Program
- Local Radio and Television News Shows were used to explain the STOP Program to the Public
- The Traffic Section has a dedicated time slot once a month on a local TV Noon News show to talk about traffic issues, including STOP
- The Program was also explained to Civic Groups such as the Cosmopolitans, Morning Optimists, Rotary Club, etc.



- When an offender is stopped for DUR or DUS, they are scheduled for a common court date – every Friday Morning at 8:15
- The STOP Officer gets the court docket and matches the STOP offenders with the docket and puts together a document of each offender scheduled for court
- The Offender document contains a photo of the driver, the last vehicle the Offender was driving when they were stopped, and the license plate number.
- Traffic and Patrol Officers are stationed in and around the courthouse parking lot on Friday mornings to wait for the offender to drive to court – which some of them do every week!
- The part the judges like is they get to watch from their office windows as we tow vehicles from the courthouse parking lot











- The Rapid City Police Department keeps BEAT books for each of our sectors
- The BEAT books contain information for the Patrol Officers on such things as Sex Offenders and addresses and STOP Offenders and their addresses
- Patrol Officers often times will sit in the area of STOP Offenders residences and do reports and watch for offenders to drive
- In at least one case, an Officer was doing a report in front of the home of a STOP Offender and noticed a lot of vehicle traffic briefly stopping at the offender's house. A traffic stop was done on one of the vehicle's as it left the house, and drugs were found
- A search warrant for that house was obtained and it was discovered the Offender was selling drugs



- As part of the strategy we also informed our tow companies on the program
- Our very first week of implementation, a suspended driver had their car towed
- The next day the offender went to the tow yard and paid to get their car our of storage
- The employee of the tow truck company that took the money from the offender for the tow happened to be the tow truck driver that initially towed the vehicle
- The tow truck driver called the police and an officer met the offender as they were leaving the tow yard
- A wrecker from a different tow company was called because of our rotation – to tow the offender's vehicle from the driveway of one tow company to its own tow yard!
