

Bike & Pedestrian Safety

In the interest of developing a customizable Bike & Pedestrian Safety Program for tribal communities to implement, the UGPTI is proactively seeking additional resources to distribute to its readership. The Pedestrian and Bicycle Information Center (PBIC) offers monthly webinars and a variety of training series applicable to



bike & pedestrian safety. This month the topic was "Addressing Speed-Related Crashes with the Focus on Protecting Children." View the <u>webinar</u> and download the <u>PDF</u> for free.

The primary focus of this webinar is learning how to prevent crashes where children

walk and bike. S*afe Routes to School* and *Vision Zero for Youth* encourages communities to prioritize safety improvements and encourages drivers to slow down, specifically where youth are walking and biking. These initiatives improve safety throughout the entire community!

We encourage your community to participate in <u>Walk to School day</u> to support youth pedestrian safety and driver safety, but to also encourage your local government officials (i.e. mayors, tribal council, etc.) to publicly commit to improving children's safety. Emergency Preparedness Handbook

Many Native American tribal governments are lacking in emergency preparedness, a part of the emergency management cycle where planning for disasters happens. These governments need assistance planning for future disasters. Federal and state governments, along with other agencies and organizations, have the knowledge and resources to help tribal governments develop emergency response plans.

This handbook is a resource to help tribes develop and implement an emergency preparedness plan for responding to natural and man-made disasters if and when they occur.

Transportation Alternatives (TA) Program

The North Dakota Department of Transportation (NDDOT) is accepting applications for Transportation Alternatives (TA) Program projects for federal fiscal year 2019.

TA provides funding for projects that include: 1) Pedestrian and bicycle projects; 2) Safe routes to school and safe routes for non-driver projects; 3) Conversion and use of abandoned railroad corridor projects for non-motorized users; 4) Construction of turnouts, overlooks, and viewing areas, operating historic transportation facilities, vegetation management practices in transportation rights of way, archaeological activities relating to impacts from implementation of a transportation project, streetscape improvements, and corridor landscaping; and 6) Environmental mitigation projects.

Tribal governments are ELIGIBLE project applicants and are encouraged to apply.
