

# Understand the Demographics of Your Fatality Rates

(Native Americans are Over-represented in Montana Fatality Statistics)



In 2006 Native Americans fatalities were:


**18%** of all Montana fatalities

71% of these related to alcohol


<8% of fatalities wore seat belts

6.2% of Montanans are Native American

# **Native American Focus**

- June 2005: Tribal Safety Conscious Planning Forum
- Oct 2005: Pilot for tribal crash data collection
- April 2006: Governor's Tri-party gathering
- Ongoing: Safe On All Roads Program, Continuing involvement in Comprehensive Highway Safety Plan, STEP overtime patrols for tribal law enforcement, equipment and training

# Conclusions

- Each tribe is a unique sovereign entity
- Traffic Codes, Data Sharing, Cross-Deputization – all Variable
  - Tribal concerns include Sovereignty and Protection of Members
- Inconsistent Crash Data
  - Exception: fatal crashes reported by MHP
- Limited drivers training due to cost
- Limited Safety Belt Use
- DUI is a major problem

# Principles from June 2005 Forum & CHSP

- Approach each tribe as a unique entity
- Involve the tribes in finding the solutions
- Allow each tribe access to resources
- Keep working toward consistent data
- Common Theme: A Culture of Safety

#### Structure

- Interns Hired with Standing in Community
- Approx. 20 Hr/Wk
- Work with Tribal Colleges to Develop and Deploy Messages
- Local Media and Events Focused

- Round Dances
- Holiday Powwows
- Basketball Games
- College semester orientation/registration
- Rodeos



# Some Results

- Alcohol Related Crashes on Some Reservations down
- Seat Belt Usage on SOAR Reservations May be Increasing
- Sobriety Culture Expanding
- Message Recognition Strong and Positive

# **Racial Profiling Prevention**

#### • History:

- Attempts to pass Primary Seat Belt Law marred by suggestions of racial profiling
- MDT received racial profiling prevention grants for 2006/2007
- Current MT bill will not qualify state for additional Section 1906 funding
- Goal of current grants: begin a new dialogue with Native Americans and work to stop racial profiling in all enforcement activities.

# **Racial Profiling Prevention Plan**

- Started with a session where MDT listened to Native Americans and Law Enforcement on Racial Profiling
- From this we learned:
  - There are significant current efforts and laws on the books prohibiting it
  - Perceptions of racial profiling sometimes based on decades old events
  - No amount of data will dispel perceptions

### MDT's Four 4 Track Approach to Racial Profile Prevention

- I. COMMUNITY AND COMMUNICATIONS
- Liaison to facilitate
  "town hall" meetings to change the dialogue

# III. SURVEYS & TRACKING

 Collect data on public perceptions and track data on implemented programs

- II. TRAINING & EDUCATION
- Deliver cultural awareness course to officers that have not received it
- **IV. DATA COLLECTION**
- develop consistent data collection and analysis capabilities regarding racial profiling

# Racial Profiling Prevention Current Status

- November 23, MDT hired a liaison to begin the town hall meetings on racial profiling prevention
  - Supported by:
    - Montana Sheriffs & Peace Officers Association
    - Montana Highway Patrol
    - Montana Law Enforcement Academy
    - Montana Department of Justice
- First "town hall" meetings will begin this year --- top priority: law enforcement agencies located near reservations
