



Inspection Data	2 years	3 years
Inspections	6 – 7 million inspections	9 – 10 million inspections
Violations	10 – 11 million violations	13 – 14 million violations
Publicly Available?	Mostly Yes (PII, Scores hidden)	Available to carriers seeking to hire.




Where does crash data come from?

- Using 2019 MCMIS Crash data:
 - 193,893 trucks and buses in FMCSA-reportable crashes
 - 5,066 involved in fatal crashes
 - 69,871 involved in injury crashes
 - 118,956 involved in tow-away crashes
 - 9,062 distinct "agencies" reporting crash data to our MCSAP Partners
 - MCSAP Partners/State Police Report: 50% of all crash data
 - 67% of fatal crashes
 - 46% of injury crashes
 - 51% of tow-away crashes


Map of Percent of State Data that Comes from Locals
