

What has WDEA been doing for members?

- Lobbied daily in the 2025 Legislature, following work of interim committees on Western ND issues
- Work closely with CCCA, a subgroup of WDEA
- Updated oil and gas tax distribution study
- Joined ND School Construction Coalition
- Engaged in CO2 Education, Opposition to Fed regs
- LoadPass Permits enhancements underway, more eastern counties added to the system
- Keep members informed through newsletter, web site, social media and community interaction



- Adjourned Sine Die just after 4:00 am Saturday morning
- 1,089 Measures Introduced (most since 2009)
- 616 Measures Enrolled
- 536 Measures Signed by Governor
- 21 Measures Pending w/ Governor
- 74 Legislative Days Used
- Total budget of \$20.3 Billion
- Major bills included Property Tax Reform, NDDOT \$2.7 billion budget, NDIC Budget, Rare Earth Minerals policy.



Energy Highlights

- SB 2397 Started as the "non oil county" definition bill. Hoghoused into innovative drilling techniques in the Bakken/Three Forks formations.
- HB 1483 Drilling incentive outside of the Bakken/Three Forks. Includes study on Stripper Wells.
- HB 1579 Study relating to the impact of large energy consumers (Data Centers) on the state's electrical grid.
- SB 2159 Allows the EERC to study nuclear waste disposal.
- SB 2014 NDIC Budget; \$25 million EOR; \$100M Pipeline Capacity



Education Highlights

HB 1476 – DPI may conduct school facility assessments.
 Result of WDEA's work on ND School Construction Coalition



- HB 1013 DPI Budget
- HB 1369 DPI Policy Bill increases teacher pay and per pupil funding to 2.5%
- SB 2275 Supports foreign language programs in early grades.
- HB 1160 & SB 2354 Bell-to-Bell Cell Phone Ban. Public and Non-Public.
- HB 1482 School bond elections. Primary/General only, even years.

Transportation Highlights

- SB 2012 DOT Budget \$2.7 billion. \$160 Million for Prairie Dog, \$230 Million for Flex Fund, Adjusts Highway Tax Distribution Fund. No Gas Tax.
- HB 1065 County and township road fund; based on road miles.
- HB 1053 Repeals road system mileage cap of 7%. Leaves 7,700 limit.
- HB 1298 Increases interstate speed limit to 80 MPH; increases fines.
- HB 1444 Adds township roads to county road system.
- SB 2183 \$150 fine for speeding in work zones when workers present.

Government Highlights

- HB 1176 Property tax credit \$1,600; 3% caps.
- HB 1577 Wastewater infrastructure.
- SB 2180 Public comment requirement for all public boards.
- SB 2308 Reduction of boards and commissions.
- SB 2230 Voter education bill.
 - Ballot Measures SCR 4008, HCR 3003, SCR 4007
- SB 2323 Hub City debt relief. 4/5% side of the GPT; \$7m Williston,
 \$2M Dickinson, \$1M Minot.

WDEA Industry Impact Study



- Member concerns that GPT distribution is not equitable
- Update the infrastructure needs for cities/counties/townships
- Evaluate adequacy of GPT revenues to local budgets
- Compare infrastructure impacts to other regions of the state
- Develop consensus of funding allocations to support needs
- Initiate strategies for any potential legislative changes
